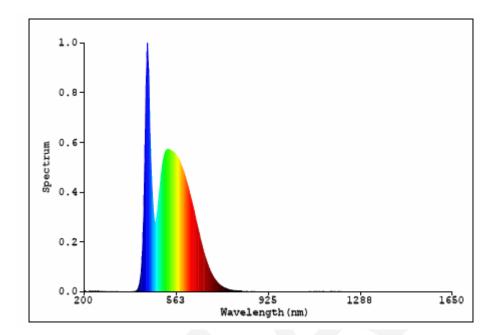

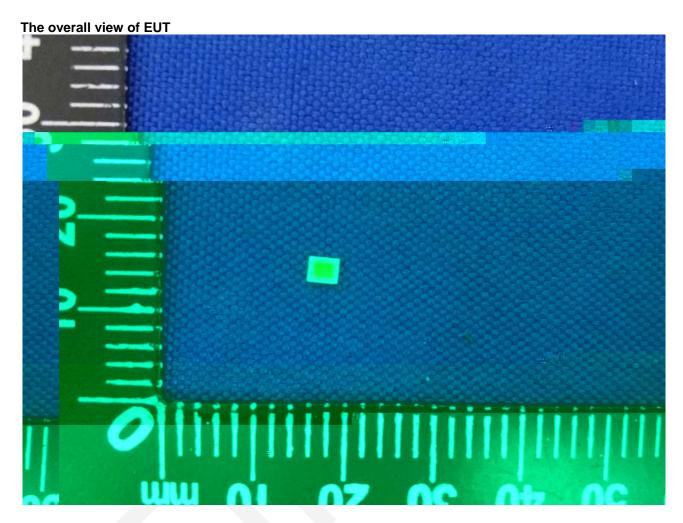


Figure of Spectral distribution
